Consultation Response to Strengthening Scottish Charity Law

Introduction

The Good Governance Steering Group (GGSG) is the college sector's advisory body on all matters relating to college governance in Scotland. The GGSG prepares and publishes the sector's Code of Good Governance as well as advising and recommending any areas for improvement. Its membership (outlined in Annex 1) includes key college sector representatives (chairs, principals, board secretaries, finance directors), Scottish Government, Scottish Funding Council, National Union of Students Scotland (NUS), Colleges Scotland, College Development Network, Scottish Trades Union Congress (UNISON/EIS) and the Office of the Scottish Charity Regulator (OSCR).

The GGSG welcomes the opportunity to respond to the Strengthening Scottish Charity Law consultation. Whilst the GGSG has chosen not to respond to each individual question set out in the consultation paper within the response, the following comments are offered as possible areas for consideration.

Key Points

The GGSG accepts, in principle, the six proposals outlined in the response however, would seek further clarity on the following proposals:

Proposal Two: An internal database and external register of charity trustees

Whilst there is no objection to this proposal, given that all college board members are public appointments and this information is already recorded by the Scottish Government, we would remind OSCR of duplicating existing registers. For example, in terms of an expanded list of disqualified trustees, college board members would only ever be excluded by Ministers on the basis of rigorous investigations.

Proposal Four: A power to issue positive directions to charities

Whilst there are no objections to this proposal, we would remind the Scottish Government that board appointments in the college sector are at the direction of Ministers and as such, college legislation would precede charity legislation in that context.

As such we would advise there is a need to ensure that OSCR is clear and consistent in the application of powers and in taking relevant legislation into account.
